ENVIRONMENTAL ENFORCEMENT AND COMPLIANCE

Instructor: Randolph L. Hill Summer 2020, Term Three, July 6–16 9:00a.m.–12:00p.m. (online)

This course is an introduction to the theory and practice of enforcement of the federal pollution control laws. The course will first discuss the basic regulatory structure of the pollution control laws and the administrative, civil judicial, and criminal enforcement tools available to federal and state regulators to ensure compliance with those laws. The course will then delve into the practice of civil enforcement, including methods for investigating and establishing potential violations, selection of the appropriate enforcement response, calculation of penalties, use of supplemental environmental projects or other innovative remedies, and practical issues arising in citizen suit enforcement. The course will also discuss key issues related to criminal enforcement, including establishment of the elements of the offense and considerations of mental state requirements and the burden of proof. Finally, the course will discuss alternatives to traditional command-and-control regulation and enforcement for gaining compliance with environmental standards.

Prerequisites

Environmental Law; Administrative Law may also be helpful.
