Syllabus

OVERVIEW: Bankruptcy is a two-credit course which meets Thursdays from 3:35 p.m. to 5:15 p.m. First class is January 11, 2018.

CONTENT: This course will provide an overview and introduction to consumer bankruptcy law. The course will introduce students to the various types of bankruptcy relief available under Title 11 of the United State Code. This course will cover fundamental bankruptcy concepts including choice of chapter, the bankruptcy estate, claims of creditors, the automatic stay provision, and the discharge order. Students will engage in practical exercises aimed at teaching students to make choice of chapter decisions through a mock client intake interview. Based on the information gathered in the mock interview, students will prepare a bankruptcy petition using the Federal Bankruptcy forms. Students will also be introduced to motion practice in bankruptcy court and be given an opportunity to prepare and argue a motion before the District of Vermont Bankruptcy Judge.

LEARNING OUTCOMES: At the end of this course students should be able to:

- 1. Distinguish between Chapter 7, 11, 12, and 13 of the United States Bankruptcy Code.
- 2. Describe the automatic stay and discharge provisions of the United States Bankruptcy Code.
- 3. Understand and identify property of the bankruptcy estate and how the bankruptcy estate is created.
- 4. Understand how creditors recover from the debtor's bankruptcy estate through the proof of claims process.
- 5. Understand, identify, and apply federal and state bankruptcy exemptions.
- 6. Demonstrate an ability to conduct a client intake interview including the ability to identify issues that may inform the choice of chapter decision making process.
- 7. Demonstrate an ability to draft and argue a motion in bankruptcy court.

TWEN SITE: There is a TWEN site for this course. Students are required to register for the site. Materials and assignments will be posted via TWEN.

GRADES: There is no final exam for this course. Grades will be determined by students' performance in the class apportioned as follows:

Class Participation: 25%
Client Intake Interview and Petition Preparation: 25%
Preparation and Argument of Motion: 30%
Exercise Assignments: 20%

TEXTS AND OTHER MATERIALS: Text and materials for this class will be available through the TWEN site. Students will use materials prepared by Chapter 13 Trustee, Jan Sensenich. The course materials will be supplemented by postings to the TWEN site as the course develops.
