### **Course Description**

It is often argued that individual food choice is the ultimate exercise of personal responsibility in our society. But what if that conventional wisdom was challenged, instead recognizing that a complex web of agricultural and food laws substantially influences what ends up on our plates, and ultimately affects the health of individuals and communities. These policies, and the regulatory mechanisms supporting them, play a vital role in determining health outcomes for our nation, and accordingly will be explored in depth in this course. In the context of these policies, the course will cover diverse public health issues including the U.S. Farm Bill, nutrition assistance programs (SNAP, WIC, and school meal programs), food access, obesity and malnutrition, food safety and foodborne diseases, genetically engineered foods, organic and other certification and food labeling schemes, and the debate about food systems and sustainability. Because many of these issues are newly emerging topics, student participation in discussions is strongly encouraged. The course will conclude with a short research paper and a brief presentation on a topic of the student's choice.

This course is an elective. There are no prerequisites, but Administrative Law or Environmental Law is strongly recommended.

The class will meet from July 9 to July 19 (Monday through Thursday), 9:00am to 12:00pm, with two 10-minute breaks. I will likely schedule at least one guest lecture to provide diverse perspectives for students, to spark ideas of interest for papers and presentations, and to offer insight into the types of careers that exist in this field.

### **Class Readings**

Our primary textbook will be FOOD, AGRICULTURE, AND ENVIRONMENTAL LAW (edited by Angelo, Czarnezki, and Eubanks), ISBN: 1585761605. The textbook will be supplemented with readings that have been selected from diverse sources (law review articles, government agencies, scientific and advocacy organizations, and mainstream media) to ensure that all viewpoints are analyzed and discussed. All readings are required unless marked as **OPTIONAL**. Optional readings might be discussed briefly in class, but are intended primarily to provide additional reading for students interested in a particular topic, as well as to provide ideas for paper topics. Students are expected to read each required document before that day's class and to be prepared to critically analyze the topics found therein during class discussions. *Please note there are readings for the first day of class*.

The weblinks can be accessed by copying them from the syllabus and pasting them into a web browser. Please note that if a weblink goes onto a second line in the syllabus, you may have to delete a space (where the link break occurs) when pasting the link into your web browser. If any of the weblinks are found to be non-operational, please email the professor immediately and a replacement link will be provided if one is available.

### **Final Exam and Grading**

In lieu of a final exam, there will be a short (5-10 page, double-spaced) research paper on a topic of the student's choice. The research paper will be due no later than noon on Sunday, July 22. *All final papers must be emailed to the professor (beubanks@meyerglitz.com) in Microsoft Word format.* On July 19, students will present to the class a short (5-10 minute) oral presentation (Powerpoint optional) summarizing the topic on which the student has chosen to write her or his final paper. In an effort to avoid duplicative research by students, all paper/presentation topics must be approved by the professor by 4:00pm on Thursday, July 12. Students may discuss topics with the professor before or after class, during class breaks, during office hours, or by email.

Grading will be conducted as follows: 20% of a student's grade will be based on class participation; 20% of a student's grade will be based on the short (approximately 8-10 minute) oral presentation on a topic of her/his choice (to be discussed with and approved by the professor); and the final 60% of a student's grade will be based on the short research paper (5-10 pages, double-spaced) on the same topic. The paper will be graded on content, critical thinking and analysis, use of source materials, grammar/spelling, and proper citation pursuant to the 20th edition of the Bluebook.
