Advanced Environmental Legal Research Summer 2018

This one-credit course will provide in-depth exposure to the most useful, efficient, and effective strategies and resources for environmental legal research, including environmental news/updating services, specialized information databases, environmental dispute resolution resources, science and statistics sources, state environmental resources, administrative law research, legislative history, archives of environmental information formerly on federal government web sites, and international environmental legal research. The course is designed to prepare environmental law students to research well while in law school and in practice.

Throughout the course students will use the resources and strategies being taught in the course to conduct research on a topic of their choice, reflecting what they have learned in this course, which they will assemble into a Research Guide/Memo.

<u>Choose a topic focused on U.S. environmental law, federal</u> and/or state.

Textbook and Assignments:

Time will be spent more with hands-on research experience than with reading about research. For those who wish to consult them, legal research textbooks are available on Reserve.

Pre-Class Assignments:

It is essential that pre-class work be done before each class.

In-class work will build on pre-class work, and students will be asked about resources explored and how they have applied resources to their Research Guides/Research Memos.

Grading:

- Be successful in using the Advanced Search option and other features of an academic law library catalog as well as through WorldCat, the world's largest online catalog, to efficiently access environmentally-related books available onsite in the library, electronically, and at other libraries.
- Select and effectively use subscription databases that contain explanatory, analytical, and practical environmentally-related resources.
- Understand that you have an ethical and professional responsibility to conduct effective environmental legal research.

- Be competent in knowing how a comprehensive Environmental Law Resources
 LibGuide can lead researchers to just about anything they need.
- Effectively identify and locate environmental legal research free web resources using VLS's *Environmental Law Research Sources (ELRS)*, a database of judiciously selected and categorized web sites.

Pre-class Reading and Assignments and applying what you've learned to your Research Guide:

- Thoroughly read the Research Guide/Research Memo instructions on the TWEN site. Determine a title for your Guide and also write a description (one paragraph minimum to one page maximum) of your Research Guide topic. Choose a U.S. federal and /or state topic. You can add an international perspective, if you wish, but the focus must be on U.S. environmental law. Print out a paper copy of this description and bring it with you to turn in during the first class.

- Environmental Dispute Resolution We'll explore these resources together in class.

Upon completion of this class, you will:

- Be knowledgeable about a variety of environmental law and news sources including through use of resources included in the VLS Environmental Law Research Sources (ELRS) database.
- Have explored social media sites and discovered the vast array of environmental law news outlets.
- Understand the difference between a general environmental news feed and a specific news alert that is based on your individual, specific search query, and gain experience in setting up thoughtful and focused environmental news alerts.
- Be knowledgeable regarding a variety of environmental dispute resolution sources as well as strategies for learning about additional EDR sources.

Pre-class Assignments and applying what you've learned to your Research Guide/Research Memo:

- ➤ Go to http://newsletters.findlaw.com/ and subscribe to at least one "newsletter" your choice. (If asked for a password, keep clicking "cancel" and you'll get to the site.)

- Find a news source related to your Research Guide/Research Memo topic or some other aspect of environmental law, using twitter, an app, facebook, reddit, etc.

 Be prepared to share recommendations in class.
- Set up a Google *News* Alert related to your Research Guide/Research Memo topic.
- Set up an alert using Westlaw, Lexis Advance, or Bloomberg Law.
- It is also possible to set up a Google Scholar Alert.

Specialized Internet resources

Upon completion of this class, you will:

- Have effectively used a variety of different types of specialized resources including a non-profit, non-advocacy environmental group which specializes in education of environmental law professionals, a mega legal research site, a legal organization site, law firm sites, and national and regional advocacy sites.
- Be aware of and recognize the biases that exist in different web sites.
- Be knowledgeable regarding how to critically evaluate the quality of a website before relying on the information the site provides, by considering authority, accuracy, comprehensiveness, and currency of the site.
- Learn how to access Environmental Information no longer available on federal government web sites through a VLS LibGuide. (In class, no pre-class assignment for this)

Upon completion of this class, you will:

- Have a deeper understanding of the environmental law materials available through Westlaw, Lexis Advance, and Bloomberg Law/BNA by effective use of practice area and content type selections, filters, specialized sources, etc.
- Have knowledge of additional reputable legal research sources commonly used by attorneys, such as CaseMaker and FastCase.

Pre-class Reading and Assignments and applying what you've learned to your Research Guide/Research Memo. Use Westlaw, AND Lexis Advance, AND Bloomberg/BNA Law:

Bloomberg Law

- In upper left corner of main page, click on "BROWSE All Content" > Practice Centers > Environmental & Safety. Explore and search for something relevant to your Research Guide/Research Memo.
- On the main Bloomberg Law page, under "Be Practice Ready...", click on Bloomberg BNA Law Reports, then Environment. Note the many resources. Choose one to explore.

Optional: Because it is important for you to be able to navigate new Legal Databases, explore the following two which are used by many practitioners, and note what looks useful to you as an environmental law professional:

CaseMaker (Access through our Databases page)

CasemakerX is a free service supported by the Casemaker Bar Consortium and its 475,000 attorney membership consisting of State Bar Associations across the U.S. Casemaker includes case law, codes & statutes, etc., including state sources not easily available elsewhere.

FastCase (Access through our Databases page)

Fastcase's libraries include primary law from all 50 states, as well as federal coverage going back to 1 U.S. 1, 1 F.2d 1, and 1 F.Supp. 1. The Fastcase collection includes cases, statutes, regulations, court rules, and constitutions. Fastcase also provides access to a newspaper archive, legal forms, and a PACER search of federal filings.

Thursday, June 7, 1-2:15

Environmental Law Resources at the State Level

Upon completion of this class, you will:

- o Be knowledgeable about resources that lead to state legal sources.
- o Become familiar state legal resources in one particular state.

Pre-class Reading and Assignments and applying what you've learned to your Research Guide/Research Memo:

Environmental Law Reporter (A VLS Database)

Under *Administrative*, there are links directly to each state agency that deals with environmental issues. *State Update* summarizes and links to recent state regulatory developments. Under *Legislative*, the *State Laws* tab takes you (for some states) directly to the environmental statutes on the individual state web site. You can also use the search box.

CaseMaker (A VLS Database)

CasemakerX is a free service supported by its attorney membership consisting of State Bar Associations across the U.S. It includes case law, codes & regulations, etc., including state sources not easily available elsewhere. For Vermont, Environmental Court Decisions are included The Administrative Codes/Rules for each state are included, and conveniently broken down by division/program/agency. For example: Environmental Management, Environmental Quality, Natural Resources, Energy Office, Agriculture and Animals, etc.

A legislative tracking service with full text and status of bills for all 50 states (and U.S. Congress). Explore a state of your choice on a topic related to your Guide.

In Search Box, type 50 state survey and note in drop down menu: 50 State Regulatory Surveys – Environmental Law; 50 State Regulatory Surveys – Regulatory Surveys – Environmental Law; 50 State Regulatory Surveys – Statutory Surveys – Environmental Law.

50 State Surveys on Lexis

In Search Box, type 50 State and note LexisNexis 50 State Survey: Statutes and Regs in the drop down menu. Environmental Law and Energy & Utilities Law are both topics.

Subject Compilations of State Laws On Hein Online (A VLS Database)

A bibliography/list of articles, reports, and books. Subjects include Environmental Protection, Energy, Natural Resources, Climate Change, Wildlife, Water Law, etc. Keyword searches are also possible.

> Explore legal resources for the state of your choice and be prepared to share how you conducted your exploration

Some possible approaches:

The resources of your state bar association. The New York Bar Association has an Environmental & Energy Law section. Vermont does not have an environment section, but, for Vermont, you will find: Practice Resources > Forms > Court Forms > Environmental Forms. Most state bar associations have a bar journal. Webcasts? News feeds?

Does your state's environmental regulatory agency or AG's Office issue news releases or opinions? How could the agency's resources be useful to you? Setting up a google news alert for the agency can yield a great deal.

Is there a listserv or twitter feed from a local environmental organization, or perhaps even from an agency?

What free primary sources are available? Are they easy to use? Is there any information on recent or pending environmental legislation? Is there a bill tracking option?

What is useful on the judiciary site? Any news feeds? Advance release opinions? Does a law library in your state list resources that are and also that are not available online? How else might a law library in your state be helpful? Is there a LibGuide/Research Guide that covers your state's legal/law resources?

- Have become knowledgeable about and searched for environmental regulations and accompanying materials presented in a variety of formats: e-cfr, FDsys, Reginfo.gov, Regulations.gov, Environmental Law Reporter, Cornell LII, Westlaw, Lexis Advance, and Bloomberg Law.
- Have explored an environmentally related federal government agency web site searching for information related to your research topic and compared the results when searching for the same information on the same agency web site using Google as your search engine.
- Have become familiar with resources that list and describe environmentally related federal government agencies.

- Be familiar with resources that list, summarize, and often provide the full text of environmental statutes.
