


New Resource Outlines Legal and Historical Context of Heirs' Property

Agriculture and Food Systems (CAFS) released a new section of our Farmland Access Legal Toolkit focused on heirs' property: a legal system that has driven devastating land loss among Black, Indigenous, Latinx, and other marginalized communities in the United States. Heirs' property is created when someone dies without a will, leaving land to multiple heirs. The new resource outlines how this system limits access to funding and wealth generation, how the land is often lost though devastating "partition sales," and why it disproportionately affects marginalized communities, particularly Black communities in the South.
