Course Objectives: A student who completes this course will:

- Gain knowledge of the interface of law, animal ethics, and animal welfare science and how these can inform policy and legal strategy to protect animals
- Learn how to interpret and apply federal animal welfare-related statutes and regulations
- Understand how animal welfare laws intersect
- Understand where the limitations, challenges, and opportunities exist in the landscape of the budding field of animal law
