INTRODUCTION

Completion of this course requires diligence, discipline, and self-motivation. Assignments and podcasts are posted in Canvas. Class will be recorded in Teams and an audio recorder. The audio recording will be posted after each class meeting in Canvas in the module: Class Recordings. Class notes are also posted in Canvas in the module: Class Notes.

All assignments are posted only in Canvas. Each module includes the reading assignment and problems; a preliminary podcast; and the lecture notes. The Lecture notes will be available <u>after</u> that assignment is discussed in class. Most modules will also include review quizzes.

Class will focus primarily on the problems that are posted for each assignment. Students are responsible for downloading and preparing the problems from Canvas. The applicable statutory provisions are the Uniform Probate Code (UPC), the Uniform Parentage Act (UPA), the Uniform Trust Code (UTC), and the Vermont statutes. They are in the Statutory Supplement that is posted in the Syllabus module in Canvas.

COURSE OBJECTIVES AND LEARNING OUTCOMES

This course teaches the fundamental principles governing the transmission of property. The specific learning outcomes are defined in terms of doctrine, skills, and values as described below. Learning objectives for each assignment are included in the assignments that are posted in the modules in Canvas.

Doctrine

1. Students should understand the basic structure of the probate process, be able to distinguish between probate and non-probate assets, and be able to evaluate the advantages and disadvantages of the probate process. They should be able to analyze a fact situation, determine whether assets or transfers will be subject to the probate process and explain their conclusion and the rationale for their conclusion.

- 2. Students should understand the intestacy process, including how and when it occurs, and the policies underlying the intestacy statutes. Students should be able to analyze the intestacy provisions regarding surviving spouses, descendants, and collateral kindred, including systems of representation and be able to apply those provisions to hypothetical situations. Students should be able to explain their conclusion and the rationale for their conclusion and be able to evaluate specific provisions.
- 3. Students should be able to explain the statutory and common law doctrines governing the execution and revocation or wills, testamentary capacity and undue influence, and construction and interpretation of wills and apply those doctrines to hypothetical situations. They should be able to explain their conclusion and the rationale for their conclusion. They should be able to evaluate specific provisions and the policies underlying these rules.
- 4. Students should understand the doctrines that protect family members from disinheritance and be able to apply those doctrines to hypothetical situations. They should be able to explain their conclusion and the rationale for their conclusion. They should be able to evaluate specific provisions.
- 5. Students should understand the doctrines governing the creation, modification, interpretation, and termination of trusts and be able to apply those doctrines to hypothetical situations. They should be able to explain their conclusion and the rationale for their conclusion. They should be able to evaluate specific provisions.
- 6. Students should understand the doctrines regarding class gifts, powers of appointment, and future interests and be able to apply those doctrines to hypothetical situations. They should be able to explain their conclusion and the rationale for their conclusion. They should be able to evaluate specific provisions.

<u>Skills</u>

- 1. Students will enhance their skills in reading and analyzing statutes, reading and analyzing cases, and problem solving.
- 2. Students will enhance their skills in identifying relevant issues, determining what legal principles are relevant, and in applying the appropriate legal principles to particular hypotheticals to justify a particular conclusion.

<u>Values</u>

- 1. Students will gain a basic understanding of client behavior and ethical principles governing representation of clients in the estate planning context.
- 2. Students will demonstrate professionalism in meeting course outcomes.

The Estates Statutory Supplement is available only in Canvas in the module: Syllabus and related materials. The Statutory Supplement contains provisions of the Uniform Probate Code, the Uniform Trust Code, the Uniform Parentage Act, the Vermont statutes, and the Internal Revenue Code. The Uniform Parentage Act, the Vermont statutes and the IRC are only available in the Statutory Supplement while most of the UPC and the UTC provisions are also in the textbook.

You are required to have the applicable statutory provisions readily available during class discussions, and you will need to refer to the statutory provisions during the quizzes and the final examination. You are strongly encouraged to print a copy of the Statutory Supplement for use during class, the quizzes, and the final examination.

In addition to the Statutory Supplement, complete versions of the Uniform Probate Code and the Uniform Trust Code are posted in Canvas in the module: Statutory Provisions. These are there for your convenience and are not required texts for the course.

3. ASSIGNMENTS

The assignments include readings and problems. The assignments are posted only in the modules in Canvas. You are responsible for reading the assigned problems and outlining a response prior to class discussion. Always note what statute, case, or other authority supports your analysis.

GRADING POLICY

The grade in this course will be based 15% on professionalism; 30% on quizzes; and 55% on the final examination.

<u>Professionalism and Participation</u> counts for 15% of the final grade and will be based on attendance, punctuality, class preparation and participation, review quizzes, responsibility, civility, respect, and meeting all course obligations in a timely fashion.

Attendance

The attendance policy is posted in Canvas in the Syllabus and Related Materials module. You are responsible for understanding and following that policy.

Class attendance is required. Absences will affect your grade. If you are absent (or considered absent) from five (5) classes, a grade of F.Wd. will be sent to the Registrar immediately. Prior notice is not required.

Class begins at 9:00 a.m. Joining class on Teams does not count as attendance.

Class Preparation and Participation

You are expected to be prepared for and to participate in class when called on. If you are not prepared, please pass. Passing can have a detrimental effect on your Professionalism grade. Class participation is measured primarily by its meaningfulness and utility to the classroom discussion. While frequency of participation matters, it is the substance of your contribution that matters more. This is a small class so you should expect to participate during every class. There will be "cold-calling," but volunteers are strongly encouraged. See the additional posting on Class Preparation and Expectations posted in Canvas in the Syllabus and Related Materials module.

You are not expected to have the correct answers in class. If you have prepared, please participate. Often the class learns more when a student does not have the correct answer initially. That allows us to work through the material together.

Review Quizzes

The review quizzes are optional, but completion counts toward the Professionalism component of the final grade. There are review quizzes for most modules. Details are included in a separate posting in Canvas in the module: Syllabus and Related Materials. Instructions, including an Honor Code statement, are included in each quiz.

Responsibility

You are responsible for the information in the Syllabus and in the other materials posted in the Syllabus and Related Materials module. You are also responsible for the readings and problems in each module. The readings and problems are not included in this syllabus but as separate Word document in each module. That allows you to download the document and use it for class preparation, your notes, and your course outline.

You are responsible for taking the "numbered quizzes" when they are scheduled. If extraordinary circumstances of an emergency nature beyond your control occur, please contact the Registrar. Because the quizzes are available over a 2.5 day period, extensions will be granted only in exceptional circumstances.

You are responsible for reading your school-related email daily.

Respect and Civility / Diversity, Equity, and Inclusion

You are expected to show respect for the Professor and your classmates. Please arrive on time and do not leave during class except for emergencies. Please turn off your cell phone. <u>Numbered Quizzes</u> will count for 30 percent of your final grade. There will be four quizzes of 10 multiple choice questions each. The maximum score that will count toward the final grade, however, is 30 points (out of a possible 40 points). The quizzes will be administered

through ExamSoft/Examplify. You should confirm that your registration for ExamSoft/Examplify is current at the beginning of the semester.

Final Examination will count for 55 percent of the final grade. It will be a modified openbook examination; you may consult only your textbook, the supplement, class handouts, material from the course web page, and any materials substantially prepared by you for this course. The exam will include essay and short answer questions.

The general exam instructions are posted in Canvas in the Assignment #21 module. Additional instructions for the final exam will be provided later in the term. The final exam reflects the materials covered in class discussion. The focus is on identifying the issues, understanding and applying the appropriate rules, and providing a detailed explanation (analysis) explicitly referring to the facts in detail.

The final exam will be administered through ExamSoft/Examplify.

Prior Examinations and Exam Review Memos

Final exam essay questions from 2018 through fall 2022 are posted in Canvas. There is an exam review memo posted for each exam. The memo is not a model answer or an issue outline, but it does discuss the issues raised by the questions.

Review Problems

There are a number of review problems, many based on prior examinations, posted in Canvas in the module: Review Suggestions and Problems. There is both a file with the problems and a separate file with the analysis. These are posted for your benefit. You are not required to access any of them, but you are strongly encouraged to use them to review and to prepare for the final exam.

Students must have satisfactorily completed, *i.e.*, received a passing grade in, Property prior to enrolling in this class.
